	Original, signed Hong Kong passport and a photocopy of the applicant's passport bio-data page must be furnished. At least 6 is validity (calculated from the date of arrival in Singapore) and one blank visa page.
	Passport type photos: 2 Two sets (one to be affixed onto the Form and the other for scanning purpose). The photograph must the following requirements: Taken within the last 3 months, coloured, must be taken against a white background with a matt of
	matt finish and taken full face without headgear (unless headgear worn in accordance with his/her religious or racial custom but the ear must not hide the applicant's features).
	Payment. Credit Card Authorization form, Certified Check, or Money Order payable to VisaHQ.hk.
	Vaccinated Travel Pass (VTP). Apply for Vaccinated Travel Pass under the Vaccinated Travel Lane.
	PRC, HK Identity Card & Permit to Travel. Original and a photocopy of the identity cards, and permit to travel between Hong and China or Macau, if any.
	Flight Itinerary. Original and a copy of confirmed return/onward air ticket or itinerary.

Other documents. The applicant may be required to furnish additional documents and information requested by the Singapore Consulate-General or our AVAs whenever necessary. Official translations of the documents are required if they are not in the English language.
Business Profile. Computer printout of the Singapore registered company's business profile (showing the names of all the directors/shareholders) obtainable from Accounting & Corporate Regulatory Authority and printed within the last 3 months.
Employment Letter. Original company letter issued by applicant's current employer stating the designation, purpose and date of visit to Singapore. Applicant who is invited by Singapore government agencies, universities or are attending
exhibition/conference/convention in Singapore are not required producing business profile. The applicant however needs to present the
original letter by the inviting organization or event organizer addressed to the applicant. The invitation letter must be signed by the invitee of the organizer and addressed to the applicant (the full name as in passport).
